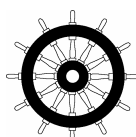

### Remarks

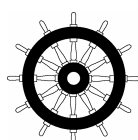
As the lifejackets are not designed to fit persons with a chest girth up to 1750 mm, suitable accessories shall be available for such persons.
