Subj: CHANGES TO TYPE-APPROVAL REQUIREMENTS FOR SURVIVAL CRAFT EQUIPMENT

The Coast Guard published an NPRM on October 5, 2020 (<u>85 FR 62842</u>) and we appreciate the comments submitted from the industry. The Survival Craft Equipment Final Rule (87 FR 68270) was published in the <u>Federal Register</u> on 14 November 2022 and goes into effect on 14 December 2022. This rule removes Coast Guard type approval requirements for nine types of survival craft equipment and replaces them with the requirement that manufacturers self-certify that their equipment complies with a consensus standard.

Under self-certification, manufacturers will produce equipment in accordance with the standard(s) incorporated by reference in 46 CFR 199.175 and mark the equipment as compliant with the applicable standard(s). The equipment listed in the table below will no longer be approved by the Coast Guard, receive a Certificate of Approval, or be marked with a Coast Guard approval number.

Current stock produced under a valid COA may be sold and ongoing production runs with the USCG approval number are valid until the expiry of the current COA.

Subj: CHANGES TO TYPE-APPROVAL REQUIREMENTS FOR SURVIVAL CRAFT EQUIPMENT

We will issue no new approvals for the above equipment. Existing Certificates of Approval (COAs) for these equipment types are valid until their expiry. Once a manufacturer's COA expires, they must transition their current USCG approvals, marked "USCG approved", to a new label that shows compliance with the applicable consensus standard. Manufacturers may elect to transition their labels to the new standard prior to the expiration of their current certificates.
