"QCYD- I 15-2-2" is a lifebuoy self-activating smoke signal with pull out ignition lanyard, producing orange smoke for at least 15 minutes.

Tested with drop height: 40 m

This lifebuoy self-activating smoke signal shall be fitted with an approved light to comply with SOLAS III/7 1.3, e.g. combined with the "Lifebuoy light, type QD2-2".

Application/Limitation
