

### 1. PRODUCT DESCRIPTION :

"Oralite FD1403-1545" (3155-0015-000-0762) retro-reflective material consists of microprisms enclosed in a transparent film. The product is acrylated polyester/metallized and the material is provided with acrylic pressure sensitive adhesive, for tape and sheeting application to Life-Saving Appliances, to assist in their detection.

The tapes or sheeting do not require an additional primer when fitted to painted wood, metallic surfaces or glassfibre. A suitable primer should be used when the tape is fitted to the following substrates:

The retro-reflective material shall be supplied with its Manual(s) for Installation, use & maintenance.
