The **HZ-CJ (Child)** is an inherent buoyant lifejacket for children. The buoyant material is expanded polyethylene covered with reddish canvas. The size is: 530 mm long, 280 mm wide and 100 mm thick. The neck opening is  $100 \text{ mm} \times 130 \text{ mm}$ . The two chest parts are closed with a 40 mm nylon belt with buckle.

Approximately inherent buoyancy: 88 N
